Date and Information:

Eligibility for Quoting:

Only vendors having experience in government sector eligible for quoting. The price is to be quoted in Indian Rupees including cost of insurance, packing, forwarding, freight charges, clearing charges and installation of then Instrument exclusive of GST and other taxes which are to be quoted separately in the BOQ. Agency commission is not permissible.

4. Submission of Tender:

The tender is to be submitted in Two Bid System (Technical Bid or Bid A & Financial Bid or Bid B).

The Tenderers are not required to submit the hard copies of Cover A (Transaction document of EMD, General Documents and Technical Specifications).

5. Evaluation of Tender:

During tender evaluation process, "Bid A" will be opened first. Those tender who would qualify the Statutory & Non-Statutory requirements on the basis of technical and commercial documents will be identified and "Bid B" i.e. financial bid of only those qualified bidders will be opened. Verification of hard copies of the audited balance sheet and Profit & Loss Accounts of the Tenders for the last three years will be made if deemed necessary before opening the Financial Bid (Bid B) of the technically qualified bidders. If found suitable on the basis of above pre-qualification, the tenderer quoting the lowest rate, will be considered as successful.

Performance Bank Guarantee :

The performance bank guarantee will be mandatory for all supplier and will not be waived in any case. The Succecful tenderers shall be required to furnished the 'Performance Bank Guarantee' from any Nationalized/Scheduled Bank acceptable to Govt. of West Bengal for Three years @ 3 % of quotated base rate per item for which the tenderer has been selected as suppliers. The performance bank guarantee will have to be renewed after completion of free Warranty period. For additional (5) Five years under the paid CMAC before transfer of the CMAC amount to bidder account mentioning of West Bengal Government pooling Account for Performance Bank Guarantee No. 000605030134 IFSC ICICl0000006 MICR 70229002 at ICICI bank, R.N. Mukherjee road branch, Kolkata on the body of Performance Bank Guarantee is mandatory vide Finance Department GO no. 2691-F(Y) dated 02/05/2017.

6. Earnest Money:

The earnest money of the tendered is liable to be forfeited if the tendered withdraws his tender as a whole or for any particular item or items at any stage after opening of the tender or fails/refuses to enter into written agreement for any or all of the items of his accepted bid within the time specified when requested to do so or fails to furnish Performance Bank Guarantee within the stipulated time. EMD should be deposited online in the Pooling Account of Government of West Bengal maintained at Bank draft in favor of : "PURULIA GOVERNMENT MEDICAL COLLEGE & HOSPITAL PURULIA ROGI KALYAN SAMITI" (A/C. NO: 0198012640653). Earnest money amounting to 2% (two percent) of the estimated value of work for which tender has been called for shall have to be deposited by all intending tenderers.

Rate:

The price is to be quoted in INR only including cost of insurance, entry tax, packaging, forwarding, delivery charges, clearing charges, installation & commissioning of the listed items including two years maintenance. The rate *should* be furnished inclusive of Transportation Cost, Insurance, Testing Charges, Incidental Charges etc. GST and any other applicable taxes etc. Should be quoted separately in the template for Bill of Quantities (BOQ). The vender must get acquainted with the sites & may visit the same from 10 am to 4 pm on any working day & satisfy himself regarding the exact requirements before quoting.

7. Order & Supply:

The tendering authority has the liberty to ask for **performance demonstration** of any item during any stage of the tender process, before placing order for supply. In case of dissatisfaction, the authority will have the right to disapprove the offer of L1 bidder and go for the next bidder. Orders for supply of the approved products will be placed with the successful tenderers after execution of agreements and such supply shall have to be made in such installments as may be fixed or spread over the period to be specified in the supply orders to be made in pursuance of the agreements. The equipments to be transported in such packaging so as to avoid damage to primary package of manufacturer. The successful tendered will have to supply within the specified time schedule that had been assured at the time of selection as supplier.

8. Withdrawal/Cancellation & Purchase Policy of Tendering Authority:

The tendering authority reserves the right to withdraw any item from the tender at any stage. The selection of such item, if already made in favor of any tenderer, shall be treated as cancelled. The tendering authority reserves the right to reject or accept any tender or part thereof at any stage or to split any tender without assigning any reason. Withdrawal of tender or any revision after submission of tender by the tenderer will not be allowed.

Purchase will, however be made following the existing purchase policy of the Govt. of West Bengal and its amendment(s) made from time to time. The purchase policy of the State Government as provided in the West Bengal Financial Rules, the policy of price preference in particular in corporate under Notification No. 10500-Fdated 19.11.04, 5400-F(Y) Dated 25/06/2012 and subsequent relevant orders should be observed in considering the tenders.

9. Important Instruction with regard to Submission of Tender:

The rate should be quoted in Indian Rupees for a particular brand or model (model no. of the offered item only must be mentioned in the appropriate column of the 'Tender Form'. Alternative offer will not be accepted). The tender shallbe cancelled for the quotation of item without its brand name, model, model no. etc. Detail information regarding the manufacturer and the item quoted in the 'Tender Form' should be furnished.

10. Spare Parts:

The Bidder will undertake that supplies of necessary maintenance equipment and spare parts will be made available for all items/equipments and complete system for at least Six years (1Year+5Years CAMC) on a continuing basis. However this does not relieve the supplier of any warranty obligation under the contact.

Guarantee/Warranty Period:

The CCTV with other accessories should be covered by free on-site comprehensive Warranty for One year (minimum) after successful installation. The tenderers must quote for 5 (Five) years' comprehensive on-site AMC of entire system (Including all spares &Labour) after the date of completion of free warranty period. The CAMC charges for 5 years to be quoted in the BOQ, will however be determined as per Government order no. 10% cost of procurement of this equipment (including cost of installation) please follow Finance Department order no 3482-F(Y) Dated 25.05.2023.

- 1) If any fault is found then their rectification should be advised to the college.
- 11) The period must not be more than two week for such communication from finding of the fault.
- 111) Any lacuna or lacunae noticed in the functioning after the installation as a result of any design or other feature fault shall be rectified by the supplier free of cost within 72 hours of call log.

After Sales Services and Maintenance Contract:

After sales service must be provided by the supplier, during and after warranty period of the accessories. Selected vendor will remain liable to attract penalty for violation of machine downtime as per agreement. The selected or his authorized servicemen has to attend the machine within 72 hours of call log. It is desirable to have a fully equipped service center in or around Kolkata. <u>Manufacturer must conform to the quality assurance and maintenance as applicable and ISO - others if any as specified is a must in quoted items.</u>

The Control Room would be under safe place with Lockable arrangement.

11. Delivery, Installation and Commissioning

- a) Delivery of the goods at the purchaser's premises shall be completed by the Supplier in accordance with the terms specified by the purchaser.
- b) The installation, test in grand commissioning of the proposed system shall be completed in accordance with the order.
- C) All items are to be delivered within six weeks from the date of placement of order.
- d) In case of distributor, the firm should be direct distributed or of manufacturing unit. Sub distributor Authorization by distributed or will not be accepted at all.

12. Penalty Clauses:

PENALTY FOR FORMATION OF CARTELOR FURNISHING OFF RADULENT/MISLEADING DOCUMENTS: If

during the tender process or at any stage during the validity of the tender period, it is found that a tenderer(s) has formed a cartel in what so ever form or name to fix up the rates or suppliers to the detriment of the fairness of the tender process, penal measures shall be initiated. Similar penal measures shall also be initiated against those tenderers who have submitted false/ misleading/ *fraudulent* document so made incorrect declarations. The penal measure will be for feature of Earnest Money, for feature of Performance Bank Guarantee if enlisted as a supplier in addition to any other legal action against the firm.

13. Appeal:

Appeal against the decision of the MSVP, Deben Mahata Government Medical College & Hospital, Purulia and then to impose such a penalty will lie with Tender Selection Committee. Review against the decision of the Tender Selection Committee (TSC) will lie with Health & F.W. Dept. of the Govt. of W.B. The Special Secretary/Secretary/Principal Secretary will be the appellate authority within the Department of Health & Family Welfare, Government of West Bengal. Before imposing any penalty as per clauses 20, 21 and 22 the concerned supplier may appeal to the authority citing the proper reasons for non-imposing the penalty as stated.

14. Agreement:

On a tender being accepted, in timation of acceptance will be forwarded to the tenderer by MSVP, Deben Mahata Government Medical College & Hospital, Purulia. After communication of the same, the tenderer will have to execute agreement in the prescribed form with the MSVP, Deben Mahata Government Medical College & Hospital, and Purulia. In case any direct purchasing unit wishes to go for a separate agreement, the head of the purchasing unit must get written permission to that effect from his controlling authority. This present document and the tender forms filled in by the tenderer or copies thereof in so far as they are not inconsistent with these terms & conditions will be in corporate as part of the agreement. Such agreement will be binding on the tenderer.

15. Validity Period of Agreement:

The contract period will be for a period 01(one) years from the date off initialization of tender which can **Be extended for a further period of 6months if Tender Selection Committee feels necessary.**

16. Inspection:

Before submitting the tender, the intending tenderers should thoroughly get acquainted themselves with the proposed supply and installation by local inspection of site and take into consideration the site condition and other criterion or effecting smooth supply. No claim what so ever will be entertained afterwards.

17. Payment Terms:

Payment will be made electronically by Govt. of West Bengal approved system after execution of due supply and successful installation as ordered, subject to:

- a) Satisfactory SITC certificate and subject to penalty clause in terms of Clauses
- b) Supply of the materials as per specification as provided in the tender documents and the catalogue. Supply of the materials must be made within the stipulated period as specified in the work orders.
