6. Previous credentials of supplying similar products/services in reputed Medical Colleges (preferably Government Medical Colleges & Hospitals/Semi Govt./PSU/Reputed Corporate Hospitals)

The Quotation is to be submitted in the drop box which will be kept at the office chamber of the undersigned on all working days in working hours from 11 am to 3 pm or may be sent by post within the due date.

Physical verification of samples to be used for rendering the services and/ or physical demonstration may be done at the discretion of the hospital authority by a team of experts to adjudge the applicability or suitability of the product for the functional requirements of the Department and the technical evaluation will be done accordingly in close observation of the product or products. General Terms & Conditions:


1. The College Campus includes all the buildings, hostels, quarters & other areas in this campus which comprises of all Floors and open area within the compound wall.
2. The Contract will be awarded for a period of "One Year" and after the expiry of the said period of contract, the contract may be extended for up to three years on mutual consent on the same rate, terms and conditions, at the discretion of the Principal, Deben Mahata Government Medical College & Hospital.
3. The sealed quotations should be dropped in quotation box kept in the office of the Principal, Deben Mahata Government Medical College & Hospital. Envelope is to be super scripted as "Quotation for Pest Control Services in DMGMCH".
4. The contractor must have valid license for handling Chemical & pesticides from government authority.
5. The contractor must take all safety precautions as per standard Govt. guidelines and they will also be responsible and liable for any laxity in this regard.
6. The agency/firm should have professionally trained personnel to carry out the pest control services.
7. The contractor shall be responsible to arrange his own necessary tools & appliances required for executing of the work.
8. Rodent treatment against rat and mice is to be carried out through trapping & baiting methods by using tracking pad, glue pad as per latest ISI Specifications.
9. Non outdated chemicals should be used and all formulation/ pesticides to be used for pest control treatment shall be safe for human beings and shall not have any detrimental effect on office equipment/furniture.
10. The contractor shall be responsible for control of pest which will include all types of pests including white ants, mosquitoes, flies, cockroaches, seasonal insects, beetles, rodents, weeds, rats, bed bugs etc. in the office and within the compound wall of the premises.
11. The Successful Contractor will have to execute an agreement on Rs.10/- (Rupees Ten only) Stamp Paper with the Principal within 15 days of issue of award of this contract.
12. Pest Control Services are to be rendered at least once in a month certified by appropriate authority.
13. Rate is to be quoted on monthly basis as consolidated rate inclusive of all taxes & charges.


