CORRIGENDUM NOTICE

The following alterations are being made in the notice inviting e-tender for washing, drying and ironing of linen through Mechanized Laundry System published vide memo no. 2433/DMGMCH dated 12.09.2024.

1. In page no. 2, point no 5 & 9 (i) will be replaced by the following clauses:

The amount of Earnest money is 2% (two percent) of the estimated amount put to tender is to be deposited by the bidder in the way as described in Memorandum no. 3975 -F(Y) dated 28.07.2016 of Finance Department, Audit Branch, Govt. of West Bengal.

Scanned copy of proof of submission of EMD in the way as described in Memorandum No.-3975- F(Y), dt' - 28/7/16 of Finance Department, Audit Branch, Govt of West Bengal /valid order from competent authority in support of exemption or relaxation claimed for EMD, if any. MSMEs registered in West Bengal are exempted from submission of EMD as per Finance Department, Go WB Notification 10500-F dated 19/11/2004, but their selection would be subject to the provisions of Notification No 6142-F(Y) dated 10/10/2017 of the Finance Department, Government of W.B. All necessary certifications in this context has to be furnished.

➤ **Deposition of earnest money:**

- a) The EMD amount of **Rs. 36,000 /-(Rupees thirty six thousand only)** has to be deposited by the bidder from either of the following payment methods:
- **NET banking** (any of the banks listed in the ICICI Bank payment gateway) in case of payment through ICICI bank payment Gateway.
 - **RTGS/NEFT** in case of offline payment through bank account in any bank

➤ **Deposition of Security money:**

- Three percent (3%) security deposit out of total tendered amount/ bid value in the form of bank guarantee has to be deposited by the selected bidder within seven (07) working days upon issuance of work order.
- In case of party (selected bidder) who is exempted from deposition of EMD has to deposit five percent (5%) security deposit out of total tendered amount/ bid value in the form of bank guarantee within seven (07) working days upon issuance of work order.


