16. Evaluation of the tenders

- (a) At the level of technical evaluation of technical bids, the bidders whose were qualified in Statutory Documents & Non-Statutory Documents, shall be bound to arrange for live demonstration on their own cost before the technical experts as and when required at a specified site by the MCH authority, failing which the tender shall be technically disqualified and no representation in this regard shall be entertained. Those Bidders who have qualified in respect of the essential & other requirements in Technical Bid will be identified and their financial bid will be opened. The financial bid of those Tenderer failing to meet the technical & other requirements of participating in the tender, financial bid will not be opened and be rejected. Final selection of the lowest bidders in respect of Financial Bid is subject to further verification.
- (b) Acceptance of the lowest tender is not obligatory.

THE DECISION OF TENDER SELECTION COMMITTEE WILL BE FINAL AND BINDING IN THIS MATTER. Tender selection - for operative convenience, single bidder will be selected on the basis of Grand total under BOQ subject to fulfillment of other tender terms and condition.

17. GUARANTEE/WARRANTY:

a. 36 months onsite comprehensive 24x7 OEM warranty including parts, and service except force majeure from the date of satisfactory installation, testing, Commissioning maintaining and handing over the equipment and of works conducted there with covered under the contract in working order.

During the Guarantee/ Warranty period the replacement of any part(s) of the equipment or rectification of defect of works will be free of cost within 24 hours If the down time exceeds seven consecutive days at any one time, the guarantee period will be extended beyond aforesaid 36 months by duration equal to the total down time during the period of warranty.

- b. If the tenderer is required to replace the rejected equipment and/ or other articles, he will replace them forthwith, but not later than a period of 14 days from the date of rejection. The tenderer shall bear all cost of such replacement, including freight, if any, of such replace or repaired equipment and/ or other articles but without being entailed to any extra payment on that or any other account.
- c. Training to be given to MCH, KOL-73 staff for operation & maintenance, troubleshooting, user level training pertaining to system after successful commissioning.

The vendor shall not disclose to any one, any information marked as confidential and communicated or made available or accessible by the Vendor during execution of the Work.

19. TEST AND INSPECTIONS

Upon completion of the installation work the tenderer/contractor, shall facilitate inspection of the equipment by Medical Superintendent cum Vice Principle Medical College & Hospitals, Kolkata-73, or her authorized representative, to inspect test the equipment and to confirm that they are installed in conformity to the required specifications and are serving the desired purpose. Any defect or failure to serve the desired purpose, discovered during the inspection will be promptly rectified and made good to the satisfaction of the M.S.V.P., or her authorized representative.

20. DELIVERY PERIOD:

- i) The delivery and installation of goods and documents shall be completed within 15 days. However consignee officer e.g. M.S.V.P., concerned shall have power to extend the delivery period on the basis of actual requirement or genuine cause intimated to them by the vendor in writing.
- ii) In case of supply order being dishonoured by the selected bidder/ vendor, security deposit shall be forfeited and the bidder shall be black listed.
- iii) Supply of the materials as per specification as provided in the tender documents and the catalogue. Supply of the materials within the supplied period as specified in the
- 21. Before submission of the Tender, Tenderer shall sign each page of all of its relevant papers mentioned in check list with date. The additional alternative and or subtractive clause (if any) shall also to be signed by the tenderer.
- 22. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors bearing on the execution of the work.

23. AGREEMENT:

The successful tenderer shall sign an agreement within 14 days from date of "acceptance of the tender" by the Tender selection committee of in the prescribed form on anon judicial stamp paper.

All legal expenses, incidental thereto shall be borne by the contractor. If the tenderer fails to sign the agreement within the stipulated time. Tender selection committee reserves the right to forfeit the Earnest money deposit submitted by the contractor.

24. VALIDITY:

Offers should be valid for acceptance for a period of 365 days from the date of finalization of tender. The quoted price will remain firm and in case of acceptance of the tender the prices will remain firm till execution of the complete order and will not be subject to the price escalation on any account whatsoever. However, the contract may be extended every 6 (six) months for a period of another one year maximum on mutual consent. Tender selection committee reserves the right to terminate the contract by giving 15 days notice and without assigning any reason thereof.

25. Bidders other than manufacturers i.e. in case of Agents/ Authorized Distributors must have to submit direct authority letter from their manufacturer. If any firm concern has submitted fake authority letter subsequently the total tender paper of the said firm concern will be treated as cancelled.

26. Progress of work:

During the period of contract the contractor shall maintain proportionate progress on the basis of a Programme Chart submitted by the contractor immediately before commencement of work and agreed to by the MCH authority. Contractor should also include planning for procurement of scarce material well in advance and reflect the same in the programme chart so that there is no delay in completion of the project.

27. TOOLS, STORAGE OF MATERIALS, PROTECTIVE WORKS AND SAFETY MEASURES:

The contractor's representative and staff shall be available at the site during the office hours /· during the execution of the works to receive instruction notices or communications from the MCH authority. The contractor shall clear away on completion of the works and make good all work disturbed.

Protective Measures: The contractor from the time of commencing the works must make suitable arrangements for watching and protecting the work and no extra will be paid by MCH authority for such services.

Safety measures: The contractor shall follow all safety measures for protecting the persons employed in the works and also protecting the works executed and the MCH property.

All measuring tapes shall be of steel and suitable scaffolding and ladders that may be required for safely taking measurement and shall be supplied by the contractor.

28. CLEARING SITE AND SETTING OUT WORKS

The site shown on the plan shall be cleared of all obstructions, loose materials and rubbish of all kinds. All holed or hollows whether originally existing or produced by removal of materials shall be carefully filled up with appropriate materials like brick/ mortar and plastered to the level as directed by the MCH authority at his own cost.

The contractor shall set out the works and shall be responsible for the true and perfect setting out of the work and for the correctness of the positions, levels, dimensions and alignment of all parts thereof. If at any time, any error shall appear during the progress of any part of the work, the contractor shall at his own expenses rectify such error, if called upon to the satisfaction of the MCH authority. The contractor shall further set out the works to the alternative positions at the site until one is finally approved and the rates quoted in his tender should include for this and no extra on this account will be entertained.

29. CONTRACTOR IMMEDIATELY TO REMOVE ALL OFFENSIVE MATTERS

No materials of offensive in nature shall be brought inside the premises.

30. ACCESS

Any authorized representative of the MCH authority shall at all reasonable times have free access to the works and/or to the workshop, factories or other places where materials are being prepared or manufactured for the work and also to any place where the materials are lying or from where they are being obtained, and the contractor shall give every facility to the MCH authority or their representatives necessary for inspection and examination and test of the materials and workmanship.

31. ASSIGNMENT

The whole of the works included in the contract shall be executed by the contractor and the contractor shall not directly or indirectly transfer, assign or sublet the contract or any apart, share or interest therein nor, shall take a new partner, without written consent of the MCH authority and no subletting shall relieve the contractor from the full and entire responsibility of the contract or from active superintendence of the work during their progress.

32. Terms and Mode of Payment

The terms of the payment are as follows:-

- a) Payment shall be made in Indian Rupees subject to recoveries, if any, by way of liquidated damages or any other charges as per terms and conditions of contract.
- b) 100% of the value of the work value will be paid after supply, Installing, Testing and commissioning of the CCTV systems at MCH premises and supported by necessary documents / test certificates etc, delivery receipts and invoices duly certified by the MCH authority.

33. COMPLETION OF WORK

The whole of the work will be thoroughly inspected by the contractor and deficiencies and defects set right. On completion of such inspection the contractor shall inform the MCH authority in writing that he has completed the work and it is ready for inspection.

On receipt of such written intimation from the contractor, the MCH authority shall arrange to inspect the work and certify completion **if the** work has been completed satisfactorily. If not, the MCH authority shall inform the Contractor the deficiencies/defects in the work and the contractor shall attend to them properly and again intimate the MCH authority for further inspection.

The work shall not be considered as complete until the MCH authority have certified in writing that it has been completed satisfactorily without any apparent defects and the Defects Liability Period shall commence from the date of such certificate

No such certificates shall be issued until the contractor clears away and removes from the site all surplus materials, rubbish items, temporary works of every kind and leaves the whole of the site and the works clean and in a workman like condition to the satisfaction of the MCH authority.

34. If any question, arises regarding problem of Installing, Testing and commissioning of the CCTV systems quality and duration of the whole of the work, the matter will be referred to the Tender selection committee, M.S.V.P., whose decision will be final and binding upon the contractor.

35. The contractor will furnish the list of employees who will be deputed to this hospital for Supply, Installing, Testing and commissioning of the CCTV systems.

36. WITHDRAWAL /CANCELLATION & PURCHASE POLICY OF TENDERING AUTHORITY:

- i) The tendering authority reserves the right to withdraw any item from the tender at any stage. The selection of such item, if already made in favour of any Tenderer, shall be treated as cancelled.

The contractor shall not be entitled to claim damage whatsoever due to such termination of the contract.

37. NO- CONVICTION CERTIFICATE:

The Tenderer will also submit an affidavit (Non Judicial Stamp of Rs.50.00 (Rupees Fifty only) in the prescribed Pro-forma attached herewith from Notary/ first class Judicial Magistrate/Executive Magistrate (Annexure II).

38. PENALTY CLAUSES:

The tender selection committee reserves the right to declare a Manufacturer or their Indian Agent/ reputed organization/firm /experienced Agency blacklisted for three (03) years due to the following reasons:

- i) If the approved tenderer withdraws from agreement after achieving the "Lowest Quoted Tenderer
