Now, the undersigned is directed to convey that Governor is pleased to re-fix w.e.f. 01.01.2020 the monthly stipend of a) Interns @ of 50% of "Reckonable amount" of Rs. 56100 (minimum pay of WBHS/WBDS of Rs.56100/-+ D.A of Rs.0/-) and b) (i) House staff/ 1st year PG Trainee, (ii) 2nd year PG Trainee, (iii) 3rdyear PG Trainee, (iv) 1st year PD Trainee (v) 2nd year PD Trainee and (vi) 3rd year PD Trainee @65%, 70%, 75%, 80%,85% & 90% respectively of the "Reckonable amount" of Rs 67320/- (minimum pay of WBHS/WBDS of Rs. 56100+NPA of Rs. 11220/- being 20%+ D.A. of Rs. 0/-).
